- Convene Public Informational Hearing per Chippewa County Non-Metallic Mining Reclamation Ordinance and WI Admin. Code NR135, as it applies to the non-metallic mining reclamation permit modification to meet the requirements of the Chippewa County Nonmetallic Mining Reclamation Ordinance, at T29N, R10W, Sec. 17, 19, 20, 29, and 30.

The public informational hearing will be conducted for the purpose of explaining and receiving comments from affected persons on the nature, feasibility, and effects of the reclamation.

Pursuant to Wis. Admin. Code NR135.20(3)(c), the subject matter and testimony at this public informational hearing shall be limited to the reclamation of the non-metallic mine site. To meet this requirement, public testimony that extends beyond the scope of the NR135.20 hearing, including matters related to traffic, setbacks, blasting, hours of operation, noise or dust control, or the question of whether to use the land for mining, will be curtailed.
